RULES

1. Set-up may begin at 9:00 a.m. Please allow time to unload and set-up. If you have a special set-up situation, please let us know on your application form. No vendor may sell without advance registration.
2. Registration forms including the Hold Harmless Agreement (attached) and table fee must be received by November 14, 2009. Space is limited and will be assigned at the discretion of the LVEJO Fundraising Committee.  
**Please note, if the Hold Harmless Agreement is not received you will not be allowed to exhibit.**
3. If the merchandise you display at the Mercado differs from that which you described on this application and is deemed inappropriate for sale, you will be asked to remove it from your display or to leave the event.
4. Applicants will receive an entrance acknowledgement and space assignment the morning of the Mercado.
5. No storm date is scheduled and fees are non-refundable.
6. All vendors will be given their table designation and one to two chairs. You must provide any other equipment that may be needed to display your merchandise.
7. Electricity is limited; please add to your registration form if it is needed.
